

The purpose of this modification is as follows:

- (1) To exercise option 1 under the subject delivery order in accordance with FAR Clause 52.217-9 – Option to Extend the Term of the Contract. As a result, the ceiling amount of the subject delivery order is increased by \$276,848, from \$517,963 to \$794,811 and the obligated amount is increased by \$260,000, from \$400,000 to \$660,000. By exercising option 1, the period of performance of the contract is extended through March 31, 2010.

Accordingly, the following section of the contract is hereby modified:

1. Paragraph 1 - CONSIDERATION AND OBLIGATION, is hereby deleted in its entirety and replaced with the following:
 - (1) The total estimated amount of this order (ceiling) is \$794,811.
 - (2) The amount presently obligated with respect to this order is \$660,000. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations under this delivery order, from date of award through this modification, is given below:

Total FY 07 obligations	\$400,000
Total FY 09 obligations	\$260,000

This modification obligates \$260,000 in FY'09 funds.

All other terms and conditions remain unchanged.
