Dear Mr. West:

This is in reference to your letter dated February 3, 2009 requesting to amend Nuclear Regulatory Commission License No. 06-30793-01. In order to continue our review, we need the following additional information:

- 1. In support of your request to authorize Dr. Faisal Hasan for materials permitted under 10 CFR 35.200, please provide one of the following:
  - a. Previous license number (if issued by NRC) or a copy of the license (if issued by an Agreement State) on which the physician was specifically named as an authorized user for the uses requested; or
  - b. Written certification, signed by a preceptor physician authorized user who meets the requirements in 10 CFR 35.290, or 35.390 and 35.290(c)(1)(ii)(G), or equivalent Agreement State requirements, that the physician mentioned above has satisfactorily completed the requirements in 10 CFR 35.290(a)(1) and has achieved a level of competency sufficient to function independently as an authorized user for the medical uses authorized under 10 CFR 35.200.

NRC Form 313A (AUD) (enclosed) may be used to document this information.
