

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to provide incremental funding in the amount of \$100,000.00 thereby increasing the total obligations from \$100,000.00 to \$200,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$200,000.00 of which \$187,786.00 represents the estimated reimbursable costs, and the amount of \$12,214.00 represents the fixed fee."

All other terms and conditions remain the same.
