SUMMARY

The subject letter and another regarding Shared PET Imaging (SPI) indicates a change of control occurred on 7/29/08 for both Medical Outsourcing Services (MOS) and SPI, with no pre-approval by the NRC; therefore, a potential violation of 10 CFR 30.34(b) occurred. You previously indicated that Alliance Imaging lawyers determined that there was no change of control and thus no need to notify the NRC.
