In accordance with 10 CFR 35.24 (c) and 10 CFR 35.14 (b), I am appointing Peter W. Blue, MD, as the interim **Radiation Safety Officer (RSO)** for NRC License Number 39-14873-01, effective 16 March 2009 through 22 May 2009. Dr. Blue is an authorized user already listed on our license. The Radiation Safety Committee approved Dr. Blue's appointment as temporary **RSO** on 29 January 2009.

Dr. Blue's tenure as temporary RSO will cover the absence of the RSO, CPT James E. Wilson while he attends a required military training course in San Antonio, TX. CPT Wilson spoke with Ms. Penny Lanzisera, NRC Region 1 about the absence as it will **span** 68 days, which is excess of the 60 day maximum authorization for appointment of a temporary RSO specified in 10 CFR 25.24 (c). CPT Wilson informed Ms. Lanzisera that the training is a Army requirement for Captains. CPT Wilson also stated that he will be reachable by telephone for **the** duration of the absence and that MAJ H. Michael Stewart, the RSO at CPT Wilson's higher headquarters, located in Augusta, GA is able to respond to any event that would require the direct attention of a Health Physicist during CPT Wilson's absence. Augusta GA, is approximately one hour away **from** Fort Jackson, SC by car. Ms. Lanzisera stated that, under these conditions, she found no objection to the **68** day absence **and** appointment of Dr. Blue as temporary RSO for this time period.
