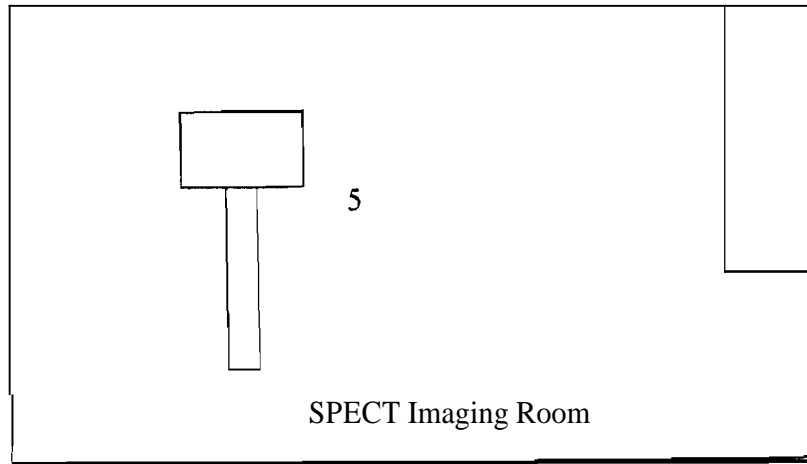

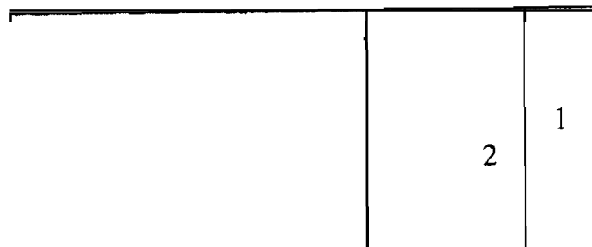

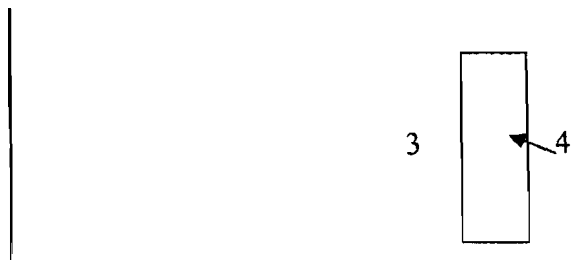


Remote Hot lab and treadmill

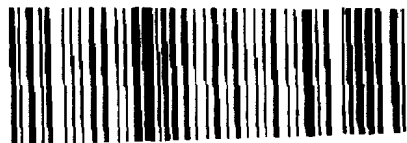
