The NRC, in Regulatory Issue Summary 2009-03 (Reference 1), has requested that 10 CFR Part 52 applicants provide a best estimate of the number of planned application submissions, their complexity, and submission date, such that NRC review requirements can be estimated through Fiscal Year (FY) 2011.

In accordance with Reference 1, UniStar Nuclear Energy is providing the following post-April 2009 through FY 2011 Combined License Application (COLA) revision schedule for the Calvert Cliffs Nuclear Power Plant Unit 3.

Revision 5 to the CCNPP Unit 3 COLA has a target submittal date of June 30, 2009. The purpose of this COLA revision is to incorporate the previously-discussed Intake Structure relocation modifications and responses to Requests for Information (RAIs) submitted to the NRC as of May 01, 2009.

Revision 6 to the CCNPP Unit 3 COLA has a target submittal in the fourth calendar quarter of 2009 (first quarter of NRC FY 2010). This COLA revision will be a general update incorporating additional submitted RAI responses, and Revision 1 to the US EPR Final Safety Analysis Report.


