**Testimony on Vogtle given to
Atomic Safety & Licensing Board,
Waynesboro, GA 3-22-09**

My name is Mal McKibben. I am Executive Director Emeritus of Citizens for Nuclear Technology Awareness (CNTA).

Also, I am a life-long nuclear professional, by education and by experience.

CNTA is the nation's largest independent, citizen-based group. We can say with confidence that we represent the views of the citizens in this area, the elected officials in Georgia and South Carolina, and technical nuclear experts. We are the *true* nuclear watchdogs who champion nuclear safety, environmental protection, and the public's interest.

The public in this area is very comfortable with nuclear enterprises because of the many excellent and safe facilities we have, including eleven nuclear power reactors in Georgia and South Carolina, a nuclear fuel manufacturing plant in Columbia, SC, a low-level waste disposal site in Barnwell, SC, a commercial nuclear laundry in Barnwell, and the massive Savannah River Site. All of these facilities have operated safely with good environmental stewardship, providing clean and green sources of electricity and thousands of good paying jobs.

The arguments offered by the anti-nuclear zealots are exaggerations or are simply specious.

We urge approval of these new reactors at Plant Vogtle. Georgia Power has proven itself. They have earned the support of the people in this area, and they have it.
