Page 2, paragraph 2 of the basic Task Order 13 is hereby deleted in its entirety and is replaced with the following:

Task Order No. 13 shall be in effect from May 16, 2008 through August 15, 2009, with a cost ceiling of \$175,323.47. The amount of \$166,974.73 represents the estimated reimbursable costs, and the amount of \$8,348.74 represents the fixed fee.
