The purpose of this modification is to reflect a reduction to the task order ceiling as noted in the contractor's revised proposal dated 12/18/08. Accordingly the task order is hereby modified as follows:

Page 2, paragraph 2 of the basic Task Order 35 is hereby deleted in its entirety and is replaced with the following:

Task Order No. 35 shall be in effect from September 11, 2008 through March 10, 2011, with a cost ceiling of \$376,157.34. The amount of \$358,245.08 represents the estimated reimbursable costs, and the amount of \$17,912.25 represents the fixed fee.
