The purpose of this modification is to increase the obligated amount by \$355,429 from \$1,111,000.00 to \$1,466,429.00 and to correct an administrative error in Modification No.004.

- (1) The obligated amount on Block 14 of modification No. 004 should have been \$1,111,000.00 instead of \$1,256,000.00.
- (2) Paragraph (f) of Section B.3 of the contract entitled: "Consideration and Obligation - Cost Plus Fixed Fee (JUN 1988) Alternate (JUN 1991) is revised to read as follows:

"(f) The amount currently obligated by the government with respect to this contract is \$1,466,429.00 of which the sum of \$1,364,140.00 represents the estimated reimbursable costs and of which \$102,289.00 represents the fixed fee."

All other terms and conditions remain the same.
