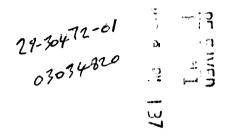

Stacey L. Meisel, Chapter 7 Trustee (the "Trustee") for Bergenline Imaging Center LLC ("Bergenline" or the "Debtor"), by and through her attorneys, Becker Meisel LLC, hereby submits this *Verified Application* In *Support of the Motionfor An Order (i) Establishing Bar Date For Filing And Serving Requests For Payment Of Chapter 7 And*  Chapter 11 Administrative Expenses, (ii) Approving The Form and Manner Of Notice Of This Bar Date, And (iii) Granting Related Relief, Including Such Other And Further Relief As The Court Deems Equitable And Just (the "Motion") and respectfully represents as follows.

### **JURISDICTION**

1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§157 and 1334. This is a core proceeding pursuant to 28 US.C. §157(b)(2)(A), (B), and (O). The bases for the relief requested herein are 11 U.S.C. §§105(a) and 503(a) and *Fed.* R. *Bankr. P.* 2002(m). Venue of the Debtor's Chapter 7 case, and this Motion, in this District is proper pursuant to 28 U.S.C. §§1408 and 1409.

#### **BACKGROUND OF THE CHAPTER 11 AND 7 CASES**

2. On June 29, 2007 (the "Petition Date"), Bergenline filed a voluntary Chapter 11 petition in the United States Bankruptcy Court for the District of New Jersey (the "Bankruptcy Court").

3. On February 11, 2008 (the "Conversion Date"), the Bankruptcy Court entered an Order converting the Debtor's Chapter 11 case to Chapter 7 (the "Conversion Order").

4. Stacey L. Meisel was appointed and duly qualified as the Interim Chapter 7 Trustee (the "Trustee") on the same day.

5. The Conversion Order specifically granted the Chapter 7 Trustee authority to operate the Debtor's business only until February 29, 2008, and then only for the limited

purpose of winding up the affairs of the Debtor and facilitating an orderly shutdown of the business by that time.

6. The Debtor operated a licensed radiological diagnostic center facility at 400- $02 \ 43^{rd}$  Street, Union City, New Jersey. The Debtor continued to operate its business as a debtor-in-possession until immediately prior to the Conversion Date, at which time the radiology services conducted at that location ceased.

7. Bergenline X-Ray Diagnostic Center Corp. ("Diagnostic") was the former owner of the Debtor's assets. Pedro Rodriguez is the principal shareholder of Diagnostic. Mr. Rodriguez was also the landlord of the premises at which the Debtor conducted its business.

8. The Trustee and Mr. Rodriguez executed an agreement dated February 14, 2008, under which the Trustee proposed to sell substantially all of the Debtor's assets to Mr. Rodriguez and/or his nominees, designees or assignees (the "Buyer"), which sale was subject to approval by the Bankruptcy Court.

9. The Bankruptcy Court approved the sale by the Trustee to the Buyer by Order entered February 27, 2008.

10. The sale by the Trustee to the Buyer closed on February 27, 2008.

#### **RELIEF REQUESTED AND GROUNDS FOR RELIEF**

11. Before taking the necessary steps to proceed to close out the Debtor's Chapter 7 estate, the Trustee wants to make sure that there are no unknown Chapter 7 and Chapter 11 administrative claims against the Debtor's estate including, but not limited to, such claims by all governmental entities ("Chapter 7 Administrative Expenses" and "Chapter 11 Administrative Expenses," respectively). Therefore, the Trustee seeks to establish a bar date by which any party or person-in-interest including, but not limited to, all governmental entities, must file a request for payment in this case and serve such request upon the undersigned.

12. The Trustee intends to *exclude specifically from the bar date requirement* the filing of any administrative claims by the Trustee, herself, for commissions and expenses, and any administrative claims for fees and expenses by the Trustee's professionals including, but not limited to, her attorneys, Becker Meisel LLC, and her accountants, Bederson & Company LLP.

13. To that end, the Trustee respectfully requests that the Bankruptcy Court enter an Order establishing June 30, 2009 at 4:00 p.m. prevailing Eastern Time as the bar date (the "Bar Date") by which all requests for payment of Chapter 7 Administrative Expenses and/or Chapter 11 Administrative Expenses must be filed with the Clerk of the Bankruptcy Court <u>and received by</u> Stacey L. Meisel, Esq., Becker Meisel LLC, Eisenhower Plaza II, 354 Eisenhower Parkway, Suite 2800, Livingston, New Jersey 07039.

14. The Trustee further requests that the Court's Order establish that in the event any holder of a Chapter 7 Administrative Expense claim and/or a Chapter 11 Administrative Expense claim does not file with the Clerk of the Bankruptcy Court and serve upon Stacey L. Meisel, Esq. of Becker Meisel LLC, so as to be received by the Bar Date, a request for payment of Chapter 7 Administrative Expenses and/or Chapter 11 Administrative Expenses, any and all such holders shall be **forever barred, estopped**  and enjoined from asserting any claim for Chapter 7 Administrative Expenses and/or Chapter 11 Administrative Expenses against the Trustee and/or the Estate of Bergenline.

15. The service list attached hereto as Exhibit "A" includes: (a) all creditors listed on Bergenline's Chapter 11 Petition Schedules and amendments; (b) all creditors who filed Proofs *of* Claims in the Chapter 7 and Chapter 11 cases; (c) all parties or their attorneys that have filed and served a Notice *of* Appearance in this case pursuant to Fed. R. *Bank*. P. 2002 at any time in these cases; (d) all employees known according to the last payroll record or who received any payments from the Trustee; (e) federal and state governmental units and taxing authorities that are listed in the Register of Government Units as it appears on this Court's website as of the date of filing the within motion; (f) the Office of the United States Trustee for the District of New Jersey; and (g) counsel to the Debtor.

16. The Trustee hereby requests that the Court approve the service list in Exhibit "A" as being adequate and sufficient under the circumstances to constitute good and sufficient notice of the bar date to be established by the Court (the "Approved Service List").

17. Attached hereto as Exhibit "B" is the Notice that the Trustee proposes to utilize to provide notice of the bar date to be set by this Court. The Trustee is proposing to (i) file Exhibit "B", or a form substantially similar thereto, on the electronic docket in this case, (ii) publish a copy of Exhibit "B", or a form substantially similar thereto, in the legal notices section of the Star Ledger newspaper for two (2) consecutive weeks (provided that the cost of such publication does not exceed \$1,000 in total), and (iii) to

serve a copy thereof on those identified in the Approved Service List, which will serve as notice of the Bar Date ("Notice of Bar Date") by which to file with the Clerk of the Bankruptcy Court and serve on Stacey L. Meisel, Esq. of Becker Meisel LLC any and all requests for payment of Chapter 7 Administrative Expenses and/or Chapter 11 Administrative Expenses.

18. The Trustee respectfully requests that the Bankruptcy Court enter an Order approving the form of Notice of Bar *Date* in Exhibit "B" as giving adequate and sufficient notice to the parties on the Approved Service List of the bar date to be established by the Court for filing and serving requests for payment of Chapter 7 Administrative Expenses and/or Chapter 11 Administrative Expenses, if sent to registered CM/ECF e-filers on the Approved Service List by way of e-filing on the Court's electronic docket, or if mailed to all other recipients by regular first class, pre-paid United States mail within seven (7) days of entry of the Order to be entered by this Court.

19. The Trustee respectfully submits that the Bankruptcy Court has the power and authority to enter the proposed form of Order submitted herewith pursuant to Sections 105(a) and 503(a) of the United States Bankruptcy Code and Fed. R. Bankr. P. 2002(m).

#### WAIVER OF MEMORANDUM OF LAW AND NOTICE

20. Pursuant to D.N.J. LBR 9013-2, the Trustee respectfully requests that the Court waive the requirement that the Trustee file a brief in support of the Trustee's Motion because no novel issues of law are presented herein.

21. Notice of the Trustee's Motion is being provided to the *Approved Service List* set forth in Exhibit "A" hereto.

22. In light of the relief requested, the Trustee respectfully submits that the notice so provided is good and sufficient notice under the circumstances, and meets the requirements of all applicable *Federal Rules of Bankruptcy Procedure*, and that no further or other notice need be given.

23. No prior application for the relief requested herein has been made to this or any other Court.

### **CONCLUSION**

24. For all of the foregoing reasons, the Trustee respectfully requests that this Court enter the Order submitted herewith or a form substantially similar thereto and grant such other and further relief as the Court deems just and proper under the circumstances.
