 The purpose of this modification number 01 is to issue a No-Cost Settlement for this contract. Per the letter from Silver Fox Synergies, LLC dated February 3, 2009, the contractor has agreed to waive any costs incurred to date and no amounts are due to the Government under the contract. This modification also deobligates the amount of (\$634,138.00).
 In accordance with FAR 49.603-6 No-cost Settlement Agreement - Complete Termination incorporate the following:
 (a) This supplemental agreement "modifies the contract to reflect a no-cost settlement agreement that terminates the contract in it's entirety.
 The parties agree as follows:
 (b) The Contractor unconditionally waives any charges against the Government because of the termination of the contract and, except as set forth below, releases it from all obligations under the contract or due to its termination. The government agrees that all obligations under the contract are concluded.
