SUBJECT: DEMAND FOR INFORMATION AND REPORTING DAMAGED DEVICES CONTAINING RADIOACTIVE MATERIAL

Dear Ms. McIntosh:

In response to your demand for information dated January 16, 2009, you are being provided an overview of the process used by the Anchorage School District to track installed, transferred and stored tritium exit signs. Recently, the ASD Maintenance Department revised the tracking procedures by incorporating the process into the computerized maintenance management system. The new process is streamlined and significantly reduces the amount of time needed to manage this information.

Installed and transferred tritium exit signs are tracked using the district's computerized maintenance management system. (Appendix A shows a sample of the data maintained on ASD locations with tritium exit signs.) All signs at all locations are accounted for and inspected biannually. Expired signs are transferred to the vendor supplying the replacement sign(s).

Though it is not ASD policy to store tritium signs, on occasion, in an effort to stretch limited budget dollars, the district will store signs removed from ASD renovation projects. Stored tritium exit signs are tracked in accordance with established inventory procedures. Expired or over-stocked stored signs are transferred to a general material licensee.

ASD currently has 1,940 installed signs and no stored signs. There are no discrepancies between these numbers and what our records indicate we should possess. In the unlikely event that the district encounters a damaged sign or discovers a sign to be missing, the damage or loss will be handled in accordance with 10 CFR 20.2201.
