The purpose of this modification is provide incremental funding in the amount of \$250,000.00 thereby increasing the total obligations from \$232,000.00 to \$482,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$482,000.00, of which \$460,634.00 represents the estimated reimbursable costs and the amount of \$21,366.00 represents the fixed fee."

All other terms and conditions of the subject task order remain unchanged including the task order ceiling of \$488,167.


