At the request of your staff, NEI has reviewed the safeguards designation of selected portions of NEI 03-09, *Security Officer Training Program*, Revision 2, Supplement 1. The removal from the SGI category of this information is needed to support the development of draft regulatory guide, DG 5015, *Training and Qualification of Security Personnel at Nuclear Power Reactor Facilities*.

We have reviewed Appendix B, Table 1 and Appendix C against the criteria in the *NRC Designation Guide for Safeguards Information*, section 128, *Training and Qualifications* and determined that these sections can be removed from the SGI category. The remainder of the document will continue to be designated SGI. Mr. Robert Norman from your staff has reviewed this change and concurs with our assessment. Therefore, the designations for these sections have been changed in the attached document.


