The purpose of this modification is to incrementally fund the contract in the amount of \$46,000.

Accordingly, the following change is made:

1. Section B.3. Consideration and Obligation – Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991), paragraph (c) is deleted in its entirety and replaced with the following:

(c) The amount currently obligated by the Government with respect to this contract is **\$662,155**, of which the sum of **\$610,281.11** represents the estimated reimbursable costs, and of which **\$51,873.89** represents the fixed fee.

Of the \$662,155 currently obligated, the funds are allotted to each task as follows:

Task A (Moore Ranch) - \$248,155
Task B (Nichols Ranch) - \$207,000
Task C (Lost Creek) - \$207,000

A summary of obligations under this contract from date of award through this modification is provided below:

This modification obligates **\$46,000** in FY09 funds.
