SUMMARY  
Your letter dated 11/25/08 <sup>(received in our office 1/13/09)</sup>, requested the addition of accelerator produced materials to your license.

Similar changes were made to 10 CFR 35.65, 35.100, 35.200, etc. on the same date with the same expansion of the scope of covered materials by revision of "Definitions."**


