The purpose of this letter is to provide a required report in accordance with 10 CFR 50.46, "Acceptance Criteria for Emergency Core Cooling Systems for Light-Water Nuclear Power Reactors" for the combined license (COL) application submitted for Vogtle Electric Generating Plant (VEGP) Units 3 and 4.

On February 13, 2009, Westinghouse Electric Company, LLC (WEC) submitted to the NRC an updated analysis in their annual report required by 10 CFR 50.46 (letter DCP/NRC2373, "10 CFR 50.46 Annual Report for the AP1000 Standard Plant Design"). Enclosure 1 of the WEC letter contains the updated analysis required by 10 CFR 50.46. Southern Nuclear Operating Company's (SNC's) COL application for proposed VEGP Units 3 and 4 incorporates by reference the AP1000 design control document (DCD), and thus, utilizes the peak cladding temperature calculations performed by WEC. Therefore, the WEC report is also applicable to the VEGP Units 3 and 4 COL Application.
