SUBJECT: SUMMARY OF MARCH 26, 2009, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On March 26, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees introduced and discussed revised versions of two FAQs (06-0022 and 07-0035). Technical agreement was reached on FAQ 06-0022. Licensees and the NRC staff discussed the remaining open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Industry representatives stated that they would continue to work within the FAQ process to resolve the following two NUREG/CR-6850 related FAQs: 07-0035 and 08-0053. The NRC staff requested that industry representatives provide a prioritized list of the NUREG/CR-6850 related FAQs.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place in April 2009.
