The purpose of this modification is to add incremental funding in the amount of \$50,000 to Task Order 59. Accordingly, the subject task order is hereby modified as follows:

Paragraph 3, page 2 of 2 under the base task order 59, is hereby deleted in its entirety and replaced with the following:
