SUBJECT: REVISED DECOMMISSIONING PLAN, ABB INC., WINDSOR SITE

Dear Mr. Otis:

In accordance with the NRC letter of August 15, 2007 (ML072210979), which established NRC oversight responsibility of ABB Inc. (ABB) decommissioning activities for the Formally Utilized Sites Remedial Action Program (FUSRAP) materials at the Windsor, Connecticut, site, NRC agreed to provide the U.S. Army Corps of Engineers (USACE) access to relevant decommissioning documents as a means to expedite timely and efficient site closure under FUSRAP.

Consistent with this agreement, enclosed is the revised decommissioning plan for the Windsor site submitted by ABB to the NRC on December 31, 2008. This revised decommissioning plan supersedes the decommissioning plan submittal by ABB dated January 29, 2007, which was provided to you under cover of the NRC letter dated March 18, 2008. This new version of the decommissioning plan is currently being reviewed by the NRC staff. Any comments you may have regarding the contents of this plan will be considered as part of our review process.
