Luminant Generation Company LLC (Luminant) submits this response to the referenced letter concerning conditions for using an online reference portal during the review of the Combined License (COL) application for Comanche Peak Nuclear Power Plant (CPNPP), Units 3 and 4. Luminant had previously proposed the use of an online reference portal (electronic reading room). The referenced letter accepts the use of an online portal and provides a list of conditions to be maintained throughout the duration of the CPNPP COL application review process.

Luminant hereby confirms that the conditions listed in the referenced letter will be maintained throughout the duration of the CPNPP COL application review process for as long as the electronic room is available to NRC reviewers. A description of the key elements of the Luminant electronic reading room follows:

The electronic reading room is password-protected and passwords will be distributed to staff directly involved in the COL application review on a need-to-know basis.

The electronic reading room disables any printing, saving or downloading functions to any location other than a printer or server controlled by Luminant.

The electronic room is sufficiently secure to prevent staff from printing, saving or downloading any documents. (Luminant cannot prevent a user from printing a single page via screen print or from taking a picture of the computer screen with a camera.)


Luminant understands that staff members who are given password access to the electronic reading room will be informed of the conditions of use by the NRC project managers. Each time any user logs into the electronic reading room, a message informs the user of the conditions for use.
