The qualification attributes of Orestes Sanchez, M.D. to meet 10 CFR 35.290 requirements were missing. Please complete the attached NRC 313A for Orestes Sanchez, M.D.

Please note that you stated that Dr. Sanchez is a Board Certified Radiologist. The NRC has an approved listing of boards for qualification. One of the boards is the American Board of Radiology from June 2006 or later. If Dr. Sanchez is board certified from them, please check number 1, include a copy of the certification, and a preceptor attestation statement.
