The purpose of this modification is to provide incremental funding in the amount of \$30,941.16 thereby increasing the total obligations from \$287,826.06 to \$318,767.22. Accordingly the contract is modified as follows:

Refer to Section B.2 entitled "CONSIDERATION AND OBLIGATION -- DELIVERY ORDERS (JUN 1988), paragraph (b) first sentence is deleted in its entirety and replaced with the following:

"The amount presently obligated with respect to this contract is \$318,767.22"

All other terms and conditions remain the same including the contract ceiling of \$365,179.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
