Enclosed for your information are reports which list all Appendix P export and import applications which were completed, received, or remain pending during the month of April 2009.

In summary, three applications were completed, seven new license applications or amendment requests were received, and eight applications are pending as of the date of this letter.

Of the eight pending applications, three are to obtain a combined import/export license, four are for export licenses and one is for an import license. Two of these applications require Executive Branch views, as the ultimate destinations for these are Iraq and India, an embargoed and restricted destination. The six remaining applications required no Executive Branch review.
