The purpose of this modification is to ensure that NRC continues to have unlimited rights to the Radioactive Material Licensing System (RADMAT) software/code/associated documentation/ etc., or any modified version thereof, no matter how OAO/LM modifies the software/code. The following will be added to Delivery Order DR-33-07-358 as Section C.40, RIGHTS TO RADMAT SOFTWARE:

NRC has evaluated several options for the migration of License Tracking System (LTS) data and functionality and has chosen to use an existing Government-Off-The-Shelf (GOTS) solution as the foundation platform for migration. This GOTS solution is called Radioactive Material Licensing System (RADMAT) and uses Microsoft .NET / SQL Server technology.

The NRC plans to submit a Change Request (CR) to OAO/LM to modify RADMAT and to perform the data migration of the LTS database to the target RADMAT platform. The CR will be submitted under Task Order 12, FSME and NMSS Systems Maintenance; however, the wording above and below will apply to the delivery order as well as to any task orders that involve the modified RADMAT software.

NRC currently holds a non-exclusive, non-transferable, royalty free license to set up a simulated Radioactive Material Licensing System (RADMAT), as developed by the State of Ohio Department of Health (ODH). The software license agreement includes, but is not limited to, the source code, custom written code, database creation scripts, a sample data set, and any other components that are required to set up a simulated RADMAT environment. NRC will continue to hold a non-exclusive, non-transferable, royalty free license for any RADMAT data, data models, source code, associated documentation, deliverables and products developed or modified by the contractor under this contract. The NRC has the right to distribute this product or any modified version of this product to other vendors for any purpose, including, but not limited to, evaluation or modification. The Contractor shall not distribute this product to other vendors for any purpose, including, but not limited to, evaluation or modification. Written permission shall be obtained from the NRC prior to use or publication of the data, deliverables or products generated using the RADMAT software.

This modification does not obligate any funding.

All other terms and conditions of this delivery order remain unchanged.
