The purpose of this task order modification is to provide incremental funding in the amount of \$35,319.00, thereby, increasing the obligated amount from \$125,000.00 to \$160,319.00, and fully funding the task order. Accordingly, the task order is hereby modified as follows:

1) On page two (2) of the Task Order award, paragraph two (2) CONSIDERATION AND OBLIGATION, section (b), sentence one (1), is deleted in its entirety and replaced with the following:

“(b) The amount obligated by the Government with respect to this Task Order is \$160,319.00.”

All other terms and conditions of the task order remain unchanged.
