11. CONDITIONS AND AUTHORIZATIONS:

A. GENERAL CONDITIONS SET OUT IN SUBPART D OF 50 CFR 13, AND SPECIFIC CONDITIONS CONTAINED IN FEDERAL REGULATIONS CITED IN BLOCK #2 ABOVE, ARE HEREBY MADE A PART OF THIS PERMIT. ALL ACTIVITIES AUTHORIZED HEREIN MUST BE CARRIED OUT IN ACCORD WITH AND FOR THE PURPOSES DESCRIBED IN THE APPLICATION SUBMITTED. CONTINUED VALIDITY, OR RENEWAL, OF THIS PERMIT IS SUBJECT TO COMPLETE AND TIMELY COMPLIANCE WITH ALL APPLICABLE CONDITIONS, INCLUDING THE FILING OF ALL REQUIRED INFORMATION AND REPORTS.

B. THE VALIDITY OF THIS PERMIT IS ALSO CONDITIONED UPON STRICT OBSERVANCE OF ALL APPLICABLE FOREIGN, STATE, LOCAL OR OTHER FEDERAL LAW.

C. VALID FOR USE BY PERMITTEE NAMED ABOVE.

D. Authorized to remove One (1) active Bald eagle nest and tree after any young have fledged (between Dec 15 and June 15) and to monitor the pair and surrounding habitat to evaluate the biological consequences of removal on the continuity of the breeding territory and reproductive performance. Permittee must bury or destroy the nest or donate to an institution authorized under 50 CFR 22.21

E. In subsequent years, authorized to disturb Bald eagles that attempt to nest within the planned construction area and surrounding 1/4 mile disturbance buffer. Eagles must be discouraged as soon as discovered and prior to the initiation of egg laying. Nest materials may be removed prior to egg laying.

F. Authorized subpermittees: Bryan D. Watt, and Libby Mojica

G. Permittee must also comply with the attached Eagle Scientific Collecting Standard Conditions.

Standard Conditions Eagle Scientific Collecting Permits 50 CFR 22.21

All of the provisions and conditions of the governing regulations at 50 CFR part 13 and 50 CFR part 22.21 are conditions of your permit. The standard conditions below are additional provisions and conditions of your permit. Failure to comply with the conditions of your permit could be cause for suspension of the permit. If you have questions regarding these conditions, refer to the regulations or, if necessary, contact your migratory bird permit issuing office. 1. If you encounter a migratory bird with a Federal band issued by the U.S. Geological Survey **Bird Banding Laboratory**, Laurel, MD, report the band number to **1-800-327-BAND** or www.reportband.gov.
2. Unless otherwise authorized on your permit, all migratory game birds taken during open hunting season must be in compliance with all applicable Federal and State hunting regulations.
3. This permit does not authorize the take or release of migratory birds on Federal lands without additional prior written authorization from the applicable Federal agency.
4. This permit does not authorize the take or release of migratory birds on State lands or other public or private property without prior written permission or permits from landowner or custodian.
5. All eagle feathers and/or whole eagle carcasses must be shipped to the National Eagle Repository. Contact: **U.S. Fish and Wildlife Service, National Eagle and Wildlife Repository, Rocky Mountain Arsenal, Building 128, Commerce City, Colorado 80022, (303) 287-2110.**
6. Your annual report may include final reports, publications, or other documentation describing the results of the project.
7. You must maintain records as required by 50 CFR 13.46 and 50 CFR 21.23(c)(4). All records relating to the permitted activities must be kept at the location identified in writing by you to the migratory bird permit issuing office.
8. Acceptance of this permit authorizes the Fish and Wildlife Service to inspect any wildlife held, and to audit or copy any permits, books, or records required to be kept by the permit and governing regulations.
9. You may not conduct the activities authorized by this permit if doing so would violate the laws of the applicable State, county, municipal or tribal government or any other applicable law.
