To Whom It May Concern:

This letter serves as notification of the change of control of St. Alexius Hospital Corporation #1 dba St. Alexius Hospital ("St. Alexius") from Envision Hospital Corporation to Success Healthcare 2, LLC, a California limited liability corporation ("Success"). On December 10, 2008, Success acquired the stock of St. Alexius Hospital Corporation #1 from Envision Hospital Corporation. There has been no change in the name or staffing of the hospital as a result of this change.

Description of Transaction

As described above, Success Healthcare 2, LLC purchased 100% of the stock of St. Alexius Hospital Corporation #1 dba St. Alexius Hospital. The name of the hospital did not change as a result of the stock transfer.

Changes of Personnel

Success offered employment to substantially all St. Alexius employees and does not intend to change any personnel or duties that relate to the licensed program. Also, there has been no change in organization, location, facilities, equipment, procedures, or personnel that would require a license amendment. Furthermore, Jeffery A. Hardy, M.D. will continue as Radiation Safety Officer and the contact person for communication concerning the license; his telephone number is (314) 865-7960. Finally, the list of authorized users and any other persons identified either on the license or in the license application as having responsibility for radiation safety or authorized to use licensed material shall stay the same. As Success has not made any changes in personnel, no information concerning the qualifications, training, and responsibilities of any personnel that will have control over licensed activities is included with this letter.


