Dear Ms. Seiler:

As I am sure you are aware, Progress Energy recently started the planning phase for an additional 200 miles of transmission lines across 10 Florida counties including Hillsborough County. One of the locations included in their study is expanding the width of an existing transmission line corridor near the Hillsborough/Pinellas county line in close proximity to the Westwood Lakes and Eagles subdivisions.


Currently, this existing transmission line corridor easement is 500 feet in width but is offset west of the county line by approximately 800 feet which offers the community a natural buffer (please see the attached graphic). The land in between the county line and Progress Energy's easement is currently owned by Pinellas County and designated as part of the Brooker Creek Preserve. *I am writing to request your support to help protect this natural buffer between the Westwood Lakes subdivision and Progress Energy's existing transmission line easement.* If Progress Energy were to use this buffer area to erect new transmission towers/lines, it would be a tremendous visual blight, affect the values of the \$300-600K homes in the communities, and greatly disrupt the habitat for native animal species that occupy this area already designated as a nature preserve.

Thank you for your return telephone call following up on my emails requesting additional information on the above project. I was looking forward to meeting you and discussing the Project. Perhaps, at the next meeting. I appreciate your agreement to discuss the Project with my wife, Jane.

It appears that your firm is responsible for the Public Information portion of this Project. You are doing a good job, but since you are a New Mexico firm you may not be aware that while you may be conforming to the letter of Florida Public Involvement statutes, you are NOT conforming to the intent of the statutes. The Public Involvement Meeting my wife and I attended at the Crescent Oaks Country Club, Tarpon Springs, February 25, 2008 did NOT address our concerns because the information presented was too general to determine if the Project would significantly affect us. The corridors presented are 2 miles wide. I am on the eastern edge of one of the corridors; a power line 2 miles to my west is of no interest to me. I need to see the exact footprint of the power line corridors to scale, on a set of detailed aerial photographs. Others affected need the same thing. I strongly suggest that before you or Progress Energy go to the regulators for permits, you hold a second round of Public Information Meetings at which a set of detailed, to scale, aerial photographs with the power line footprints shown to scale are available. I recommend a scale of 1" = 500' or larger. No final decision as to what Progress Energy attempts to permit should be made until you hold those Public Information Meetings and consider the public comments that result.

Other comments:

- Progress Energy should not require interested parties to keep track of the project by logging in to a website. Your firm should have a list of interested stake holders that receive routine updates on the Project.
- The website is NOT kept up to date. You are showing the same very un-detailed maps you were showing in February 2008.
- The people that answer the information line have no knowledge of the project. They can only offer to send an "Information Package." The Information Package is out of date like the website.
- With the exception of your return telephone call, emails to Progress Energy requesting information and Project updates are not properly responded to. You get an automated email response that directs you to the out-of-date website and to a phone number, that gets you the unknowledgeable person that offers to send you the out-of-date information package.
- Most of the information on the website and in the information package is PR boilerplate of what a great, careful, and responsible company Progress Energy is.



Dear Governor Crist::

Our Legislature just added two groups of citizens who are protected by Florida law from abuse. You may not realize that many residents of Brookridge Subdivision in Hernando County are aged and/or handicapped physically. Some have age or injury-related brain disabilities. Many are dependent on assistive devices that require environmental modifications, and in need of frequent assistance in their homes.

Does "abuse" include exploitation? I thought it did. Progress Energy has recently announced that it intends to take over 170 Brookridge homes near the fence that divides PE's current territory from Brookridge. Asked for further information that could clarify what this neighborhood looks forward to, a PE rep gave a statement to two local newspapers that PE had no intention of enlarging its territory past the present line. A couple of days later, two representatives came to an informational meeting for our residents. They modified the statement to a (paraphrased) declaration of no intention to take over Brookridge property; except that later on, they might change their intention.

As the clock ticks, a neighbor has just remarked that her 67-year-old husband now cannot retire, because if their mortgaged property goes by eminent domain, payment of today's assessed valuation will not bring them enough to buy another home. Others cannot remodel or even sell, because this announcement makes the property undesirable or eventually unretainable.

On PE's side, they have chosen the time when property values have dropped cruelly to inflict eminent domain on elderly, disabled and low-income people living in mobile homes that they have made accessible for themselves. If that's not exploitation, I don't know what is. PE has chosen the most vulnerable of this community's citizens to rob at will, at a time when the big guys will benefit and the little ones will lose. PE held a series of "information" meetings for our residents, who roasted in line in the summer sun for as much as two hours. There was no offer of transportation or other help meeting their needs. Most such events include the offer of help for the disabled to attend..

I would have gone to one, but was warned by those who had been there that I could not be safe with no help assured. Some simply left.

I have a reverse mortgage that is covering necessary medical and logistical expenses. I am assured by the bank that I cannot be removed from my property while the mortgage is in effect. If PE takes action that evicts me, I have no other place to live. I'm told that my property will be "impacted" but there's nothing about what this means. If my home becomes uninhabitable or dangerous to me, what do I do? What do all of us do? How will we afford the sharply increased assessment fees, which will remain the same even if homes are eliminated?

I implore you to refuse Progress Energy Florida's building plan that will confiscate or make worthless numerous properties belonging to this retirement community's residents.

How is it permitted under the new law for the elderly and those with disabilities to be clearly targeted in PE's proposed action?

My disabilities are multiple and age-related. I will be 81 next month. I walk with difficulty, using assistive equipment. I have progressive pulmonary disease, diabetes, failing eyesight and circulatory disease. I was widowed three years ago and still live alone with nearby medical care and support from neighbors with similar conditions as well as experienced Brookridge staff. My disability is considered moderate.

Many of my neighbors have conditions that are much more severe. We all need release from this current stress. Most beneficial (and humane) would be a written statement from Progress Energy that there will be no intrusion into Brookridge subdivision as they enlarge their nuclear power capabilities. PE itself has indicated that there are other ways to skin that cat. They might cost more, but do the big guys always win?

Re: Progress Energy's Proposed Transmission Line Corridor

Dear Sir:

First let us express our concern and shock that our Board of County Commissioners were not notified in advance, nor invited to meet with Progress Energy prior to the resident area meetings concerning the installation of the 500kV transmission lines through Hernando County.

We feel several questions leading to concerns exist in regards to the corridor choices that are currently on the table and under review for Hernando County: These are questions raised from Peco's very own literature:

- First, why would PECO base the selection of a corridor, as stated in their literature, primarily on the **"most economic route?"** We would hope they and the County Commissioners would also be concerned with the negative aesthetics the 165 foot high - tension poles will create as they bisect our county.
 1. **"Based on past evaluations, underground transmission lines have not proven to be better than overhead because of extremely high cost."** Basically then, the main reason overhead, unsightly poles are **"better"** is because they are **cheaper!**
 2. **Progress Energy looks at a number of possible routes for the line, considering "length of line" and "economics"**. Since the recipients of most of the 200 miles of wires and poles are located in an area south of Tampa, not Hernando County, it would seem building the power plant in an area south of Tampa would be more efficient as to the delivery of service. Perhaps the communities south of Tampa are reluctant to have the negative scenery created in their neighborhoods by 165' high - tension poles.
 3. If economics is their major concern as the literature implies, how then can they justify excessive compensation / pay increases to their executive personnel? According to the St. Petersburg Times, April 4, 2008, **"their Florida CEO, and the North Carolina executives for PECO received increases between 2006 and 2007 amounting to 66% for Jeff Lyash in Florida, and a greater increase to those in North Carolina. With the 66% Mr. Lyash went from \$1.54 million to \$2.56 million."** To see a compensation boost exceeding a million dollars in one year is certainly a

dream come true. How about spending some of that windfall to insure the Hernando area corridor is based on the healthiest, most environmentally sound, and aesthetically appealing construction possible?

Let's look at what appears to be a favored corridor according to some of the representatives from PECO... The Suncoast Parkway. Locating the transmission lines along the Suncoast WILL:

- Negatively impact Hernando County Airport in regards to economic growth potential of the facility, flight patterns, and auxiliary air operations including:
 1. National Guard Unit Air Wing which, on alert status, patrols the current nuclear power facility in Citrus County
 2. Impact U.S. Coast Guard exercises based there
 3. Impact the Hernando County Sheriffs air operation
 4. Impact Bay Flite helicopter operations
- Negatively impact the State recreational bike path, which parallels the Suncoast Parkway through Hernando County. How safe will it be to exercise on that path?
 1. The representative from PECO stated: **"The emissions would not be a danger since you would not stand alongside or under one of the towers for any period of time."** Yet many bikers do the entire length of the bike trail from Citrus through Hernando County and into Pasco County. What of walkers and joggers, who use the path on a daily basis? What is considered **"for any period of time?"**
 2. A PECO representative stated there are two reports about health and safety issues. When asked if they are in agreement on health and safety emission issues, both he and the literature handed out said..."**No!**" So what is the answer?

Another question that should be asked is what of property devaluation in the established growth areas of the County? How will this effect property taxes and potential income to the County? How will the County be compensated for this loss of revenue?

1. **Compensation to the property owner for the easement is based upon the "difference in the value of the property before and after construction of the transmission line" and then only on the few feet of property actually acquired.**
2. As property values in the chosen corridors are devalued, what will be the overall effect on County values and tax revenue:


One last question, why does Progress energy not look at the more eastern area of the county where open land still exists? Delivery of electric power is to be to northern Pinellas County then eastward into Polk County and the Lakeland area. A diagonal route to the Lakeland area would appear to be the shorter route and would pass through these lesser developed areas of

Citrus, Hernando, and Pasco Counties directly to the ultimate destination of the power. The western area of all three counties affected by the proposed transmission lines are highly developed with gated communities responsible for a goodly portion of tax revenues generated in the County. Surely we do not wish to devalue these properties?

For these and many more reasons, it is the position of the Silverthorn Board of Directors that the negative impacts of the Suncoast Parkway Corridor as stated in this letter, along with many more dire ramifications for the residents of Silverthorn as well as the residents of the County are enough to disqualify the Suncoast Parkway corridor from consideration.


