Dear Ms. Johansen:

The purpose of this letter is to inform you that on June 1, 2009, there will be an organization change at U. S. Silica Company (U. S. Silica). On that date, Mr. Jack Pryor, named as Radiation Safety Officer (RSO) in Provision 11 of License No. 47-09375-07 will be leaving the company. In his place, U. S. Silica has appointed Mr. Gregory S. Fell to serve as interim RSO until such time as his appointment has been approved via amendment of License No. 47-09375-07.

Mr. Fell, who is a long-standing employee of U. S. Silica and who has worked with and around fixed nuclear level gauges for a number of years, is now responsible for recommending the type and number of staff and resources necessary for full implementation of the U. S. Silica radiation protection program and compliance with License No. 47-09375-07. He also has the responsibility and authority for terminating any work activities that do or may violate regulatory or U. S. Silica requirements for radiological protection. Mr. Fell's other duties and responsibilities include, but are not limited to the following:

- Assessment of radiological hazards and ensure the implementation of appropriate radiation safety precautions;
- Ensuring that the use of licensed material is by or under the direct supervision of Authorized Users;
- Ensuring that all users participate in the necessary internal and external exposure monitoring;
- Ensuring licensed materials are secured against unauthorized removal at all times when not in use;
- Performing routine inspections of all restricted areas; and


