On May 18, 2009, an authorization to use the TRIGA and MTR basket modules manufactured in accordance with updated basket drawings in the Model No. NAC-LWT package was issued. The Safety Evaluation Report (SER) issued with the authorization letter contained an incorrect date in the Conditions section. The final condition of the authorization specifies that it expires on May 31, 2010. The SER does not have the correct date listed in the Conditions section, which should have mirrored the expiration date of the authorization letter, May 31, 2010. The correct expiration date is reflected in the Conclusion section of the SER. This error on the SER does not affect the use of the letter authorization.

The authorization letter, dated May 18, 2009, amends Certificate of Compliance No. 9225 for a period of approximately one year, expiring on May 31, 2010, to allow the use of TRIGA and MTR basket modules manufactured in accordance with the updated NAC International drawings.
