Dear Mr. Linder:

Please find enclosed the April 2009 Monthly Restoration Reports for Mine Units 2, 3, 4, and 5. Wellfield recirculation continues in Mine Units 2 and 3 to create a hydrologic bleed in preparation for re-starting the RO circuit. Mine Units 4 and 5 are in ion exchange. The reverse osmosis (RO) units continue to be run on a limited basis to test for leaks and to verify that the instrumentation is performing properly.

The bioremediation study continues in Mine Unit 4. The injection of EOS into the formation was completed on April 8, 2009. The wells in the study area have been shut down for 30 days. When they are re-started, samples will be collected to determine the effect the EOS has had on the formation.
