The purpose of this modification is to exercise option period 1 thereby extending the period of performance from May 24, 2009 through May 31, 2010 and increasing the contract ceiling by \$24,000.00 from \$23,250.00 to \$47,250.00. Accordingly the contract is modified as follows:

- (1) Refer to Section A.1 entitled "PRICE/COST SCHEDULE & PERIOD OF PERFORMANCE" subsection labeled Period of Performance is deleted in its entirety and replaced with the following: "This contract shall commence on May 25, 2008 and will expire on May 31, 2010" (2) Refer to Section A.2 entitled "CONSIDERATION AND OBLIGATION-COST REIMBURSEMENT (JUN 1988) ALT 1 (JUN 1988) paragraph "a" is deleted in its entirety and replaced with the following: "(a) The total estimated cost to the Government for full performance under this contract is \$47,250.00"
