Scott,

The libraries that were selected to display copies of the Levy Environmental Report were chosen based on the combination of a number of factors. These selection factors included the population of the town, distance from the proposed nuclear plant, direction from the proposed nuclear plant, county library system, hours of operation for the library, as well as other factors. Our general approach was to examine all of these factor in combination with one another and select one library in a relatively large town that was north, west, and south of the proposed nuclear plant.

The NRC considered several facilities near the Levy County site to hold the public scoping meetings. The Plantation Inn was preferred because it met NRC's and the public's needs during the Public Outreach Meeting held in June 2008, and it is within a reasonable distance to the proposed Levy County site. Because of the difficulty of reserving a conference hall at the Plantation Inn over the holiday season, the Florida National Guard Armory was identified as a reasonable alternative to facilitate the public scoping meetings. NRC is open to recommendations on facilities that can be used to accommodate public scoping meetings in the Inglis-Yankeetown area.
