NRC Inspection Report No. 05000305/2008201, dated September 5, 2008, identified a preliminary Greater than Green finding. Dominion Energy Kewaunee, Inc. (DEK) participated in a Regulatory Conference to provide additional information associated with the preliminary Greater than Green finding on October 6, 2008. In a December 18, 2008 letter, the NRC provided their conclusion that two findings of very low security significance (Green) and associated non-cited violations (NCVs) existed. The NRC also requested that DEK keep them informed of the status of the corrective actions for these NCVs. Attached is a list of the corrective actions associated with the NCVs along with their current status.
