TD/FR 2008-03 AND TD/FR 2008-05

The NRC received two requests from the French Government seeking consents for imports (returns) of radioactive waste from AREVA-SOMANU to Duratek Services. The first, dated March 11, 2008, is identified as TD/FR 2008-03, and it appeared to correspond to IW024, which was issued on November 20, 2008 and authorized the return of waste resulting from work performed by AREVA-SOMANU on a water pump from the DC Cook nuclear power plant. The second, dated May 7, 2008, is identified as TD/FR 2008-05, and it also appeared to correspond to IW024, but was later determined to correspond to IW018, which was issued on December 14, 2007 and authorized the return of waste resulting from work performed by AREVA-SOMANU on equipment from the Surry nuclear power plant. The confusion arose because the cover letters for both requests refer to proposed returns of radioactive waste resulting from work on DC Cook equipment. Stephen Dembek (OIP) approved (signed) TD/FR 2008-05 on November 24, 2008, and it was sent to the French Government as well as to the French Embassy in Washington, D.C.

Subsequently, when contacted by the French Embassy about the status of TD/FR 2008-03, OIP staff recognized that there seemed to be some confusion about the two requests and that clarification from interested parties was needed.
