The purpose of this modification is to provide incremental funding in the amount of \$20,814.60 thereby increasing the total obligations from \$165,541.52 to \$186,356.12. Accordingly the contract is modified as follows:

Refer to Section B.2 entitled "CONSIDERATION AND OBLIGATION -- DELIVERY ORDERS (JUN 1988), paragraph (b) first sentence is deleted in its entirety and replaced with the following:

"The amount presently obligated with respect to this contract is \$186,356.12"

All other terms and conditions remain the same including the contract ceiling of \$186,356.12.
