By letter dated January 29, 2008 (Reference 1), Louisiana Energy Services, LLC (LES) provided a summary of changes to the records required by Title 10 of the Code of Federal Regulations (10 CFR) Part 70.72(a)(2) that did not require pre-approval under 10 CFR Part 70.72, pursuant to the requirements of 10 CFR Part 70.72(d)(2). By letter dated May 4, 2009 (Reference 2), the NRC requested certain facility change information to be submitted within 15 days of receipt of its letter. The letter was received by LES on May 6, 2009. The following 70.72s were requested:
