In Management Directive 9.20, "Organization and Functions, Office of the Chief Financial Officer," the Commission delegated to the Chief Financial Officer the authority to develop and promulgate rules as defined in the Administrative Procedure Act (5 U.S.C. 551(4)), subject to the limitations of that memorandum.

The enclosed final rule amends 10 CFR Parts 170 and 171. These amendments are necessary to implement the requirements of the Omnibus Budget Reconciliation Act of 1990, as amended, to recover approximately 90 percent of the U.S. Nuclear Regulatory Commission's fiscal year 2009 budget authority through fees.

The final rule is consistent with Commission fee policy decisions, does not constitute a significant question of policy, nor does it amend regulations contained in 10 CFR Parts 7, 8, or 9 Subpart C concerning matters of policy. I find that this rule is within the scope of my rulemaking authority and therefore I am proceeding to issue it.
