The purpose of this modification is to: (1) exercise the option for CLIN B.25.2E in accordance with Contract Clause B.17, entitled, "Period of Performance," thereby extending the contract period of performance through May 31, 2009. As a result of this action, the ceiling amount of the contract is hereby increased by \$65,716.00 from \$4,166,116.00 to \$4,231,832.00, and (2) provide incremental funding in the amount of \$72,000.00, thereby increasing the obligated amount of the contract from \$4,102,512.00 to \$4,174,512.00.

Accordingly, the contract is hereby modified as follows:

1. Subsection, "B.24 CONSIDERATION AND OBLIGATION," is deleted in its entirety and substituted with the following in lieu thereof:

"CONSIDERATION AND OBLIGATION

- (a) The total estimated cost to the Government for full performance under this contract is **\$4,231,832.00**.
- (b) The amount currently obligated by the Government with respect to this contract is **\$4,174,512.00**.
- (c) It is estimated that the amount currently allotted will cover performance through **May 8, 2009**"

2. Subsection B.17 - PERIOD OF PERFORMANCE, is deleted in its entirety and substituted with the following in lieu thereof:

"The contract shall commence on August 1, 2003, and will expired on May 31, 2009."
