

The purpose of this modification is to:

- 1. Increase the contract ceiling.
- 2. Provide incremental funding.
- 3. Revise Section B.4 Consideration and Obligation Delivery Orders.

Contract NRC-10-07-399 is hereby modified as follows:

- 1. The ceiling of the contract is hereby increased by \$15,000.00 from \$782,000.00 to \$797,000.00.
- 2. Incremental funding in the amount of \$15,000.00 is hereby obligated. Funds are increased by \$15,000.00 from \$782,000.00 to \$ \$797,000.00.
- 3. Section B.4 Consideration and Obligation Delivery Orders is hereby revised as follows:
  - "(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$797,000.00.
  - "(b) The amount presently obligated with respect to this contract is \$797,000.00.
