However, in response to RAI question 02.05.04-8 (PGN RAI ID #H-0390), Progress Energy Carolinas, Inc. (PEC) stated that a replacement was being requested from WEC for Figure 2.4-2 of WEC Report TR-85 (APP-GLR-GW-044) Rev 0. WEC has since confirmed that the subject figure is still applicable for AP1000 even though it no longer appears in Revision 1 of TR-85. Therefore, no replacement figure is necessary and no additional or revised response is required for this RAI.
