4. Only microcurrie quantities of Krypton-85 are handled for the calibration of analytical laboratory equipment. The current radiation safety program includes training, audits, and laboratory QC procedures which will remain unchanged.
5. All records, including decommissioning related items, will remain onsite.
6. Linde LLC will abide by all the constraints, conditions, requirements and commitments of the current NRC License 29-18430-01

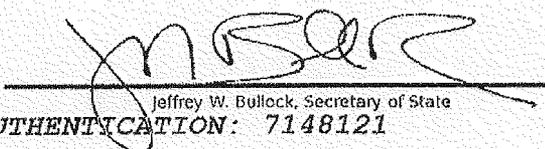
