**TENNESSEE VALLEY AUTHORITY (TVA) – ENDORSEMENT OF NUCLEAR

In a letter dated May 18, 2009, NEI requested that the Nuclear Regulatory Commission (NRC) and the Federal Emergency Management Agency (FEMA) extend the comment period for the proposed rule on emergency planning and preparedness regulations in 10 CFR Parts 50 and 52 (see 74 FR 23254) and the following related guidance:
