SUBJECT: SUMMARY OF MAY 21, 2009, CATEGORY 2 MEETING REGARDING  
THE NATIONAL FIRE PROTECTION ASSOCIATION STANDARD 805  
FREQUENTLY ASKED QUESTION PROCESS

On May 21, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Participants discussed NRC comments on FAQ 07-0035, which had been distributed to the industry in December 2007. Licensees presented a clean version of FAQ 07-0039, Revision 2. Licensees discussed a future FAQ related to the use of the NFPA 805 change evaluation process to implement new shutdown strategies. Licensees and the NRC staff discussed the remaining open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on June 25, 2009.
