SUBJECT: STAFF ATTENDANCE AT 2009 ANNUAL MEETING OF THE  
INSTITUTE OF NUCLEAR MATERIALS MANAGEMENT

The staff requests the Office of Nuclear Security and Incident Response (NSIR) and the Office of Nuclear Material Safety and Safeguards (NMSS) management support four staff members and detailee from the Division of Security Policy attend the July 2009 annual meeting of the Institute of Nuclear Materials Management (INMM) to present papers, take part in a panel discussion, and participate generally during other presentations and interacting with other domestic and international safeguards and security professionals.
