Thank you for participating in the public meeting on May 6, 2009, regarding the pending license renewal application from Nuclear Fuel Services (NFS). During the meeting you asked a question I was unable to answer and I agreed to follow-up on the issue. On June 8, 2009, I called you to offer the information I had found. You requested that I provide the information in writing. This letter responds to that request.

The license amendment which approved the new configuration management program was NFS Amendment 82 issued May 22, 2008. This amendment is available from our Agencywide Document Access and Management System (ADAMS) using the following accession numbers:
