The purpose of this modification is to 1) Exercise Option Year 2 to extend the term of the contract from June 3, 2009 to June 3, 2010; 2) increase the ceiling amount of the contract from \$209,311.94 to \$294,221.40, an increase of \$84,909.46; and 3) Revise Section #3 Definitions B. of the Statement of Work.

1. On page B-1, B.3 CONSIDERATION AND OBLIGATION – FIRM FIXED PRICE (JUN 1988); revise the sentence to read the following:

“The firm fixed price of this contract is \$294,221.40.”

2. On page C-1, C.1 STATEMENT OF WORK, revise the following sections:
 - On page C-1, #3 Definitions B. – Full-day of training means a six and ½ hour training session. The actual class time is from 8:30 a.m. – 4 p.m.
3. On page C-11, Section C.12 DURATION OF CONTRACT PERIOD, is deleted in its entirety and substituted with the following in lieu thereof:
4. The period of performance of the contract will be June 4, 2007 through June 3, 2010, with four one-year option periods.
